2. Approval of the Meeting Minutes from October 11, 2023

3. Approval of the Final Budget for FY 2023-2024

Executive Director Wagoner goes through the items that have changed from the preliminary budget. Director Creegan asked for clarification on the Wellness line item. Accountant Rob Merritt recommends moving the amount that is expected to be used to pay off outstanding leases from Capital Outlay to Ambulance Lease/Remount. Director Rice moves to approve the final budget with the changes for line items Capital Outlay and Ambulance Lease Remount. Director Creegan seconds. No further discussion. 4. Approve Revision of the Bylaws to be Consistent with JPA Agreement Requiring Final Budget to be Approved by October First of each year

Attorney Nick Clair states that the JPA is subject to the Health and Safety code for fire districts, so he amended the language in the bylaws to meet the statute requirements. Director Creegan moves to approve the revision of the Bylaws to be consistent with the JPA Agreement requiring the Final Budget to be approved by October first of each year. Director Rice seconds.
